Tightening torque of the 3 bolts increased after prior check.

Tightening torque of the attachment bolts readjusted periodically.

2. ACCOMPLISHMENT INSTRUCTIONS

A. General

Not applicable.

B. Operational Procedure

- 1. <u>Increase in the tightening torque of the 3 bolts (V) which secure splined bushes (C)</u> (as per FIGURE 1, View A), (corresponds to MOD 072323).
 - Remove the MRH as per work card 57.20.401 or 57.2.401.
 - Remove bolts (V) (remove and check the bolts one by one).
 - Check for possible cracks as per (MTC 20.02.09.101 or 20.02.09.102), using dye penetrant inspection or magna flux inspection, especially in the bolt head-to-bolt shaft connection area.

NOTE : Any bolt affected by a crack is to be scrapped and replaced with a new bolt, see paragraph 3.B.

- Fit bolts (V) (checked or new) which secure the splined bushes.
- Apply new dry tightening torque of 8 to 10 m.daN (as per FIGURE 1, View B).
- Install the MRH as per work card 57.20.401 or 57.2.401.
- 2. Readjustment of the tightening torque of the 3 bolts (V) which secure splined bushes (C) (as per FIGURE 1, View B).

Adjust the dry tightening torque to 8 to 10 m.daN as per MTC 20.02.05.404, paragraph 1.2.2.




